RELIGIOUS LIBERTY IN ENGLAND

UNALIENABLE RIGHTS

“We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness... That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, – That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new government...” *United States Constitution (1776)*

AN INBORN PRINCIPLE

“The framers of the Constitution recognized the eternal principle that man's relation with his God is above human legislation, and his rights of conscience inalienable. Reasoning was not necessary to establish this truth; we are conscious of it in our own bosoms. It is this consciousness which, in defiance of human laws, has sustained so many martyrs in tortures and flames. They felt that their duty to God was superior to human enactments, and that man could exercise no authority over their consciences. It is an inborn principle which nothing can eradicate.”—*Congressional documents (U.S.A.), serial No. 200, document No. 271. GC 295.3*

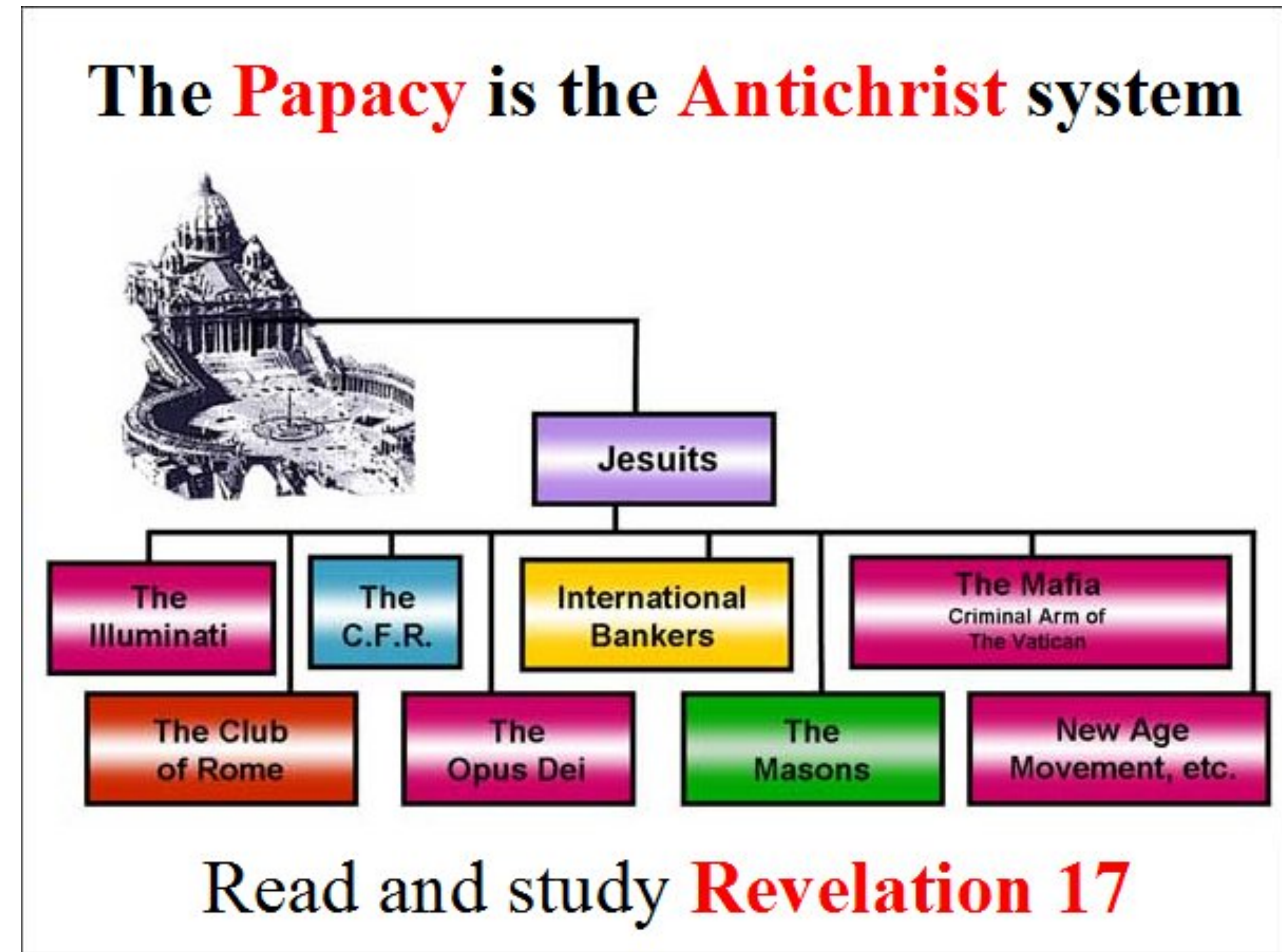

FREEDOM OF CONSCIENCE

“Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.” *1st Amendment US Constitution*

CHECKS AND BALANCES

The Constitution of the United States divides the federal government into three branches to make sure no individual or group will have too much power:

- Legislative—Makes laws (Congress, comprised of the House of Representatives and Senate)
- Executive—Carries out laws (president, vice president, Cabinet, most federal agencies)
- Judicial—Evaluates laws (Supreme Court and other courts)

Each branch of government can change acts of the other branches:

- The president can veto legislation created by Congress and nominates heads of federal agencies.
- Congress confirms or rejects the president's nominees and can remove the president from office in exceptional circumstances.
- The Justices of the Supreme Court, who can overturn unconstitutional laws, are nominated by the president and confirmed by the Senate.

Barrett joins Chief Justice John Roberts and Justices Clarence Thomas, Samuel Alito, Sonia Sotomayor, Neil Gorsuch, and Brett Kavanaugh. To date, there have only been 16 Catholic justices — out of 115 justices total — in the history of the Supreme Court. (1789)

The total number of Trump Article III judgeship nominees to be confirmed by the United States Senate was 234, including three associate justices of the Supreme Court of the United States, 54 judges for the United States courts of appeals, 174 judges for the United States district courts, and three judges for the United States Court of International Trade. Trump did not make any recess appointments to the federal courts. In terms of Article I courts, Trump made 26 appointments: 10 for the United States Court of Federal Claims, seven for the United States Tax Court, six for the United States Court of Appeals for Veterans Claims, two for the United States Court of Appeals for the Armed Forces, and one for the United States Court of Military Commission Review.

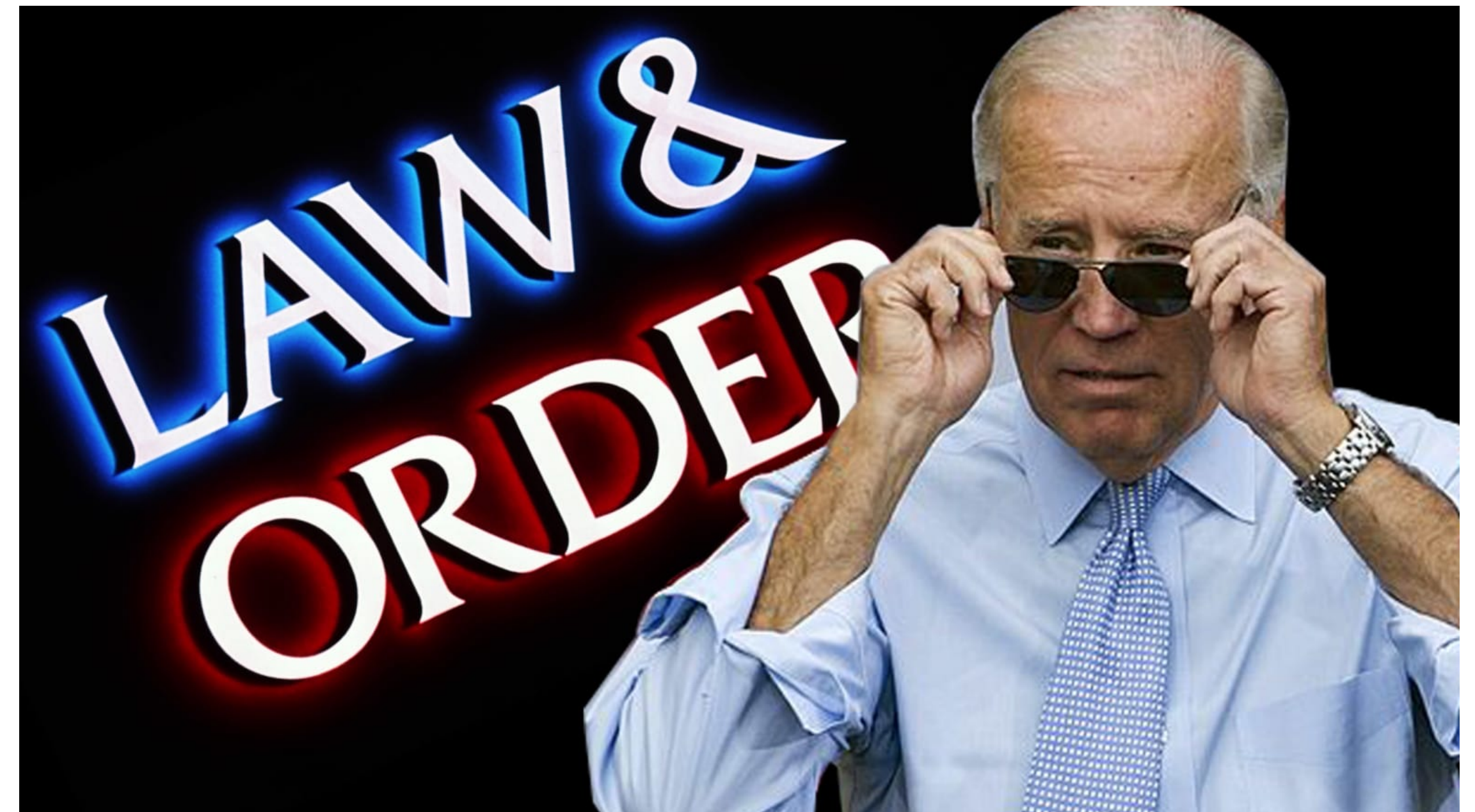


BIDEN PUBLIC DEFENDERS

“The Democratic-controlled Senate voted 52-41 Monday to confirm Gustavo Gelpi to be a judge on the 1st U.S. Circuit Court of Appeals, based in Boston, making him the... eighth new judge with experience as a public defender. That is as many as presidents Donald Trump, Obama, George W. Bush and Bill Clinton landed in their first years combined, said Chris Kang, the chief counsel of Demand Justice. “It really is amazing how far Biden has shifted the paradigm,” Kang said.

“This is going to be an important part of his legacy.” With the latest confirmation, Biden is outpacing every other president since Richard Nixon in confirming circuit judges, who have the last word in most federal cases — although the pace will be difficult to maintain.” (10/18/21)



LEGISLATIVE SPEAK

“On February 20, 1905, the Supreme Court, **by a 7-2 majority**, said in *Jacobson v. Massachusetts* that the city of Cambridge, Massachusetts could fine residents who refused to receive smallpox injections. In 1901, a smallpox epidemic swept through the Northeast and Cambridge, and Massachusetts reacted by requiring all adults receive smallpox inoculations subject to a \$5 fine. In 1902, Pastor Henning Jacobson, suggesting that he and his son both were injured by previous vaccines, refused to be vaccinated and to pay the fine. In state court, Jacobson argued the vaccine law violated the Massachusetts and federal constitutions. Before the Supreme Court, Jacobson argued that, “compulsion to introduce disease into a healthy system is a violation of liberty” but the Supreme Court rejected Jacobson’s arguments. Justice John Marshall Harlan wrote about the police power of states to regulate for the protection of public health: “The good and welfare of the Commonwealth, of which the legislature is primarily the judge, is the basis on which the police power rests in Massachusetts,” Harlan said “upon the principle of self-defense, of paramount necessity, a community has the right to protect itself against an epidemic of disease which threatens the safety of its members.”

“When a separate question of vaccinations —state laws requiring children to be vaccinated before attending public school —came up in 1922 in *Zucht v. King*, Justice Louis Brandeis and a unanimous court held that *Jacobson* “settled that it is within the police power of a state to provide for compulsory vaccination” and the case and others “also settled that a state may, consistently with the federal Constitution, delegate to a municipality authority to determine under what conditions health regulations shall become operative.”

“There are two forms of gene therapy currently being researched, somatic-cell gene therapy and germ-cell gene therapy. Supporters of gene therapy focus their endorsement on four primary arguments including scientific freedom, effect and utility, potential for disease eradication, and reproductive freedom. Gene therapy has a strong opposition, based on well-founded arguments and concerns. Four strong criticisms of gene therapy research are its irreversible nature, the potential effects on the gene pool, informed consent (or lack thereof), and risk of harm... Somatic-cell gene therapy research seeks to alter or manipulate specific organ or tissue cells. Germ-cell gene therapy does not seek to cure a disease currently being suffered, rather it seeks to alter the individual's genome so that a disease-causing mutation will not be inherited by the individual's progeny.”

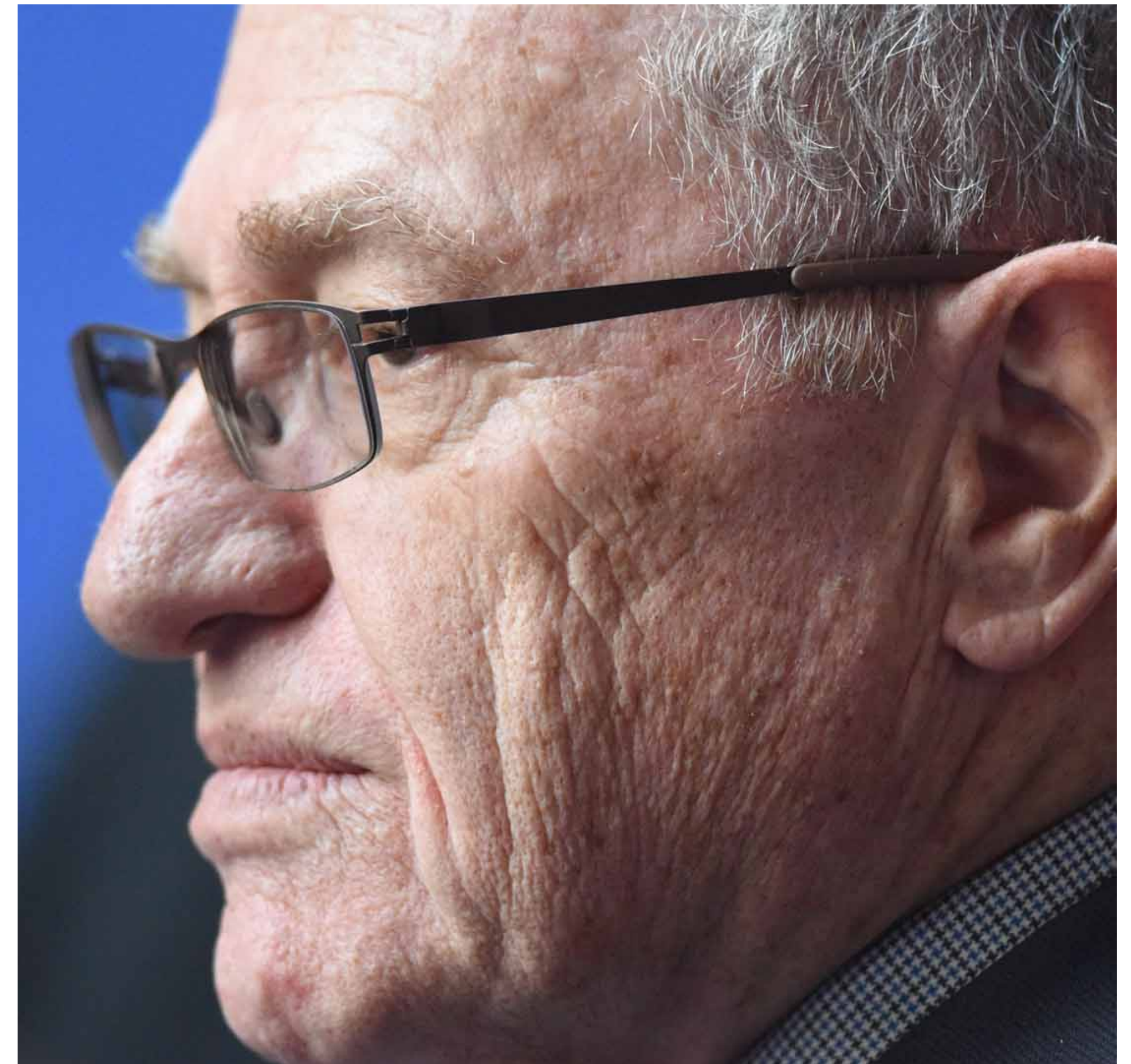

STAND YOUR GROUND

Castle Doctrine: The castle doctrine originated in England around 1600. It gets its name from the famous maxim “a man’s house is his castle,” which has become one of the most [deeply rooted principles](#) in Anglo-American jurisprudence. The castle doctrine gave individuals the right to protect their homes using deadly force without being obligated to retreat. [English citizens](#) at this time felt the need to protect themselves from intrusion by the government, by the King, and by criminal strangers. They developed the castle doctrine so that even the [“poorest man”](#) living “in his cottage” would possess the right to defend himself and his family without fear of criminal prosecution.

Stand Your Ground: Stand your ground laws move the castle doctrine principle into the public square. Generally speaking, a stand your ground law does not impose an obligation to retreat from public places a person is legally allowed to be. Stand your ground laws seek to provide immunity to victims of violent assault, no matter where that assault takes place. While stand your ground laws can obviously be abused, they draw upon centuries-old principles of self-defense and the defense of others.

THE CAPSTONE: SAVING HUMANITY

SETTING THE PRECEDENT

In *McGowan v. Maryland* (1961), the Supreme Court considered the constitutionality of Maryland's Sunday closing laws. Several employees at a department store were convicted of violating the laws and appealed their convictions on the grounds that the laws violated both the Free Exercise Clause and Establishment Clause. The Court first found that the employees did not have standing to bring the Free Exercise claim because they did not specifically state how the law burdened their ability to exercise their religion. Regarding the Establishment Clause claim, the Court found that, while the original purpose of Sunday closing laws was to promote a day of rest consistent with the Christian religion, modern statutes are driven by the more secular concern of providing a uniform day of rest for all citizens. The choice of Sunday, a day of significance to most Christian sects, did not prevent the state from achieving its secular goal of providing for the public welfare.

As soon as I shall be convinced, I will instantly retract all my errors, and will be the first to cast my books into the fire. What I have just said, will show that I have considered and weighed the dangers to which I am exposing myself; but far from being dismayed by them, I rejoice exceedingly to see the gospel this day, as of old, a cause of trouble and dissension. This is the character, the destiny, of God's word. Said Christ, ‘I came not to send peace, but a sword.’ God is wonderful and terrible in his counsels. Let us have a care lest in our endeavors to arrest discords we be found to fight against the holy word of God, and bring down upon our heads a frightful deluge of inextricable dangers, present disaster, and everlasting desolation.... I might cite examples drawn from the oracles of God. I might speak of Pharaohs, of kings of Babylon or of Israel, who were never more contributing to their own ruin than when, by measures in appearance most prudent, they thought to establish their authority. God ‘removeth the mountains, and they know not.’ *4SP 132.2*
